Item 5.02 Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.

On October 1, 2018, we restructured certain business units. We expanded the role of our Chief Operating Officer, Mr. Marc Umscheid, to include certain oversight functions of our dermatology unit. With this increase in responsibility we increased Mr. Umscheid's base salary to \$250,000.

We also promoted Mr. Tom Devine to be our General Manager for our re-branded Sonoma Dermatology unit, which was previously IntraDerm™ Pharmaceuticals. We promoted Melissa With to be our General Manager of our Acute Care and Trade unit.

On October 1, 2018, we terminated the President of our dermatology unit, Mr. Jeffrey Day, effective immediately. We are negotiating a separation agreement with Mr. Day which will outline whether Mr. Day is entitled to any severance payments or compensation under his employment agreement.
